- Bidders must be individuals or organizations that are legally allowed to transact.
- Bids must be electronically submitted to the email address provided below.
- Bids must clearly state the asset(s) being bid for and the amount offered.
- Assets have a minimum reserved price (minimum acceptable price) below which the asset shall not be sold.
- Successful bidders must collect assets immediately after full payment confirmation from Yalelo.
- The selected successful bidder must pay for the asset(s) within 48 hours. Successful bidders will be responsible for all taxes related to the transfer of ownership of the awarded truck or equipment.
- Payment shall be made by bank transfer to Yalelo's account and no cash shall be allowed.
